- 1. The candidate shall have to produce the original documents at the time of interview & joining, In case of selection, failing which, the candidature shall be cancelled and no right on the contractual appointment can be claimed for this advertisement.**

The post is purely temporary and will be filled on contractual basis initially engagement will be for 01 year which is extendable for 02 more years (01 year at a time) whichever earlier subject to requirement of the services of the YP in the organization and satisfactory performance of the candidate after evaluation by an officer of the level of ADG/Director.
3. Candidate shall have no right to claim regular appointment at the Institute, as the post is purely contractual and is co-terminus.
- 4. Candidate having essential qualifications only would be allowed to appear in the Walk in Interview.**
5. Concealing of facts or canvassing in any form or misinformation shall lead to disqualification or termination and further action may be initiated against the candidate as deemed fit by the Director, ICAR-ATARI, Zone-IV, Patna.
